

REPP Data Protection Policy

- ProtectingREPP is committed to keeping your personal data secure. Under the General DataPersonal DataProtection Regulation1 ("the Regulation") REPP acts as the controller of your
personal data and has an obligation to process your personal data in a lawful,
transparent and fair manner.2 Where you provide us personal data of any
individual other than yourself, you undertake that this information is provided
with the consent (for collection, use and disclosure) of such individual and you
will inform them of this Policy.
- Information We May Collect In fulfilling its mandate to support small scale renewable energy projects in sub-Saharan Africa REPP may collect certain information in relation to you. Examples of the information we may collect include: your name, telephone number, email address, date of birth, business profile/history, professional qualifications, education details and/or employment details. In addition, we may collect information on you in the fulfilment of certain legal obligations (for example antimoney laundering legislation). Examples of the information we may collect in this manner include: your home address or a copy of your passport. We will try to avoid collecting sensitive data, but this may be necessary on occasions (such as determination of PEPs) and if so we will ensure that such sensitive data is protected in accordance with the Regulation.

On What Basis Do The basis on which we collect, store, use, disclose and/or destroy ("process") your personal data include the following lawful grounds: Personal Data?

- Your consent;
- Processing is necessary for compliance with our legal obligations; and/or
- Processing is necessary for implementing the terms of any contract between REPP and any entity that you represent and/or control.
- Where Do We
Keep YourWe are committed to the security of your data and it is accessed on a "need to know"
basis. All third parties that process or store data on our behalf have entered data
processing agreements designed to keep your data safe. Due to the geographic focus
of REPP your data may be transferred outside the European Economic Area ("EEA")
and may be processed by staff of the REPP Manager based outside the EEA. We will
take all reasonable steps to ensure your personal data is treated securely.

- Your Rights The Regulation gives you certain rights in relation to your personal data, including:
 - The right to know if we hold your personal data, and, if we do, the right to access and if necessary, correct the information if it is inaccurate, incorrect or out of date;
 - The right to ask us to delete your personal data provided that we do not have a legal obligation to retain your personal data;
 - The right to withdraw your consent to us processing your personal data; and
 - The right to have your information transferred to another data controller.
